Terms and Conditions & Code of Conduct (Updated: 22nd September 2024)

Terms and Conditions

1: Information and Data

(a) The information and data which is provided within your child's registration form will be held on Computers, Devices, and manual records at All-Stars Football Academy [A.S.F.A].

(b) Some player information maybe be passed on to third Parties such as Tournament Organisers or other Clubs we may be playing on Tour such as Full Name & Date of Birth if required. Other information may be required such as Birth Certificates or Passports for proof of age.

2: Disclaimer

(a) A.S.F.A. reserves the right to postpone or cancel any of its sessions or events at anytime, due to weather conditions and unforeseen circumstances, but will endeavour to notify parents as soon as possible via text and/or email.

(b) All programmes, events, and trips and venues are subject to change according to venue availability, time, satisfactory number of participants, and other factors beyond A.S.F.A.'s control. We may also change, postpone or cancel any courses/programmes due to these factors.

(c) A.S.F.A. photographs and videos may be taken of registered participants on any of our programmes, events, and trips. These pictures and videos maybe used, reproduced and/or published in A.S.F.A. Publications, Websites, Social Media, Including magazines, Advertising, News reports, and on our website. This also includes sharing of images with A.S.F.A. Sponsors, Partners and Associated Clubs.

(d) Parent/Guardian authorise A.S.F.A. coaching staff to administer or approve any medical treatment deemed necessary to the participant, in your absence.

(e) A.S.F.A. reserves the right to remove any disruptive participants, parents/guardians and supporters from its programmes, events, and trips that may cause areas of concern for A.S.F.A.

(f) Although A.S.F.A. staff will take every precaution to prevent participants from injury or harm, the academy does not accept liability for medical expenses injuries that may be incurred during any of its programmes, events, and trips.

(g) Parents/guardians take full liability for their participants who may cause intentional damage to property and/or equipment of A.S.F.A. or the venue in which the programmes take place. Participants who are found causing damage will be invoiced the cost of such damage and payment of such invoice must be made prior to attending the next session unless discussed with the Academy Director/Head Coach.

(h) Parents/Guardians and Players are responsible for their own insurance in case of injury or cancellation of any trip or tour. A.S.F.A. Can not be held liable in recovering the cost of travel, accommodation and any other costs incurred.

3: Conditions of Registration

(a) Confirmation of registration for any programme, event, and/or trip will be on receipt of the full registration fee and a current registration form. All registrations will need to be approved by the All-Stars Football Academy at the start of each season.

(b) Participants are selected for the majority of A.S.F.A. programmes, events, and trips. Selection is made by the A.S.F.A. Director/Head Coach.

4: Refunds

(a) There are NO refunds once the participant has been registered and paid for A.S.F.A. programmes, events, and trips, as this confirms their place.

5: Medical Conditions/ Allergies / Special Needs

(a) You are required to inform the A.S.F.A. director of any medical conditions, allergies, or special needs your child may have.

6: Foreseeable risks or discomfort

(a) It is possible that participants may experience some mild muscle soreness due to unaccustomed exercise and activities related to football. Such mild muscle soreness (aching symptoms) may last for 2-3 days after participating in the programme. An appropriate warm up will be included in the sessions to reduce the likelihood of this occurring.

7: A.S.F.A. Invitational Academy

(a) Players need attend trainings on a regular basis each term. Being an Invitational Programme, participants need to prioritise and commit to A.S.F.A. trainings and gamedays.

(b) Players who demonstrate any ongoing behavioural issues may be suspended or removed from the academy for a period deemed suitable by the A.S.F.A. Director/Head coach.

(c) A.S.F.A. Invitational Academy players will not attend or represent any other Private Football Academy/Coaching while being part of the Invitational A.S.F.A. Academy unless agreed with A.S.F.A. Director/Head Coach.

(d) A Participants place within the Academy is reconsidered by the A.S.F.A Director/Head Coach at the start of each season. Winter being Term 2 & 3 and Summer Term 4 & 1. No Academy players place is guaranteed.

Code of Conduct

These Course Regulations form part of the terms and conditions of registration. Parents/Guardians and participants agree that:

(a) All participants attending A.S.F.A. will be accompanied by a parent/guardian or responsible caregiver for the full duration of the programme. Once players reach the Invitational Academy, they will need to arrive 5 minutes prior to the session, parents may leave but participants will need to be picked up at the end of the session on time.

(b) All Parents/Guardians and Supporters must demonstrate acceptable behaviours while attending A.S.F.A. programmes, events and trips, while at football grounds and facilities. This includes no smoking/vaping no alcohol, and/or offensive language and/or behaviour.

(c) Be supportive and respectful to A.S.F.A. staff, participants, and their families.

(d) Participants must comply with any additional rules and regulations that apply at any location where our programmes, events and trips may be held and all instructions given from All-Star Football Academy staff.

(e) All Participants, Parents/Guardians and Supporters must not bully, threaten, or behave in a way that may be a danger to others during A.S.F.A. programmes, events, and trips.

(f) Participants must wear the correct A.S.F.A uniform, football boots, shinpads or appropriate gear as specified by A.S.F.A. during all programmes, events and trips.

(g) All Parents/Guardians, Supporters and Participants must adhere to A.S.F.A.'s 'Silent Sideline' while attending programmes, events, and trips. This includes matches against opposition outside of A.S.F.A.

These codes of conduct will be enforced by All-Star Football Academy Staff. If a parent/guardian, participant, and/or supporters fail to comply with this code of conduct, in whole or in part he or she may be removed from the academy without refund, as the safety and well-being of all participants is our priority.
